Developments of the Situation in the  
Republic of Sudan

**The Council of the League of Arab States convened an Extraordinary Session at the Ministerial Level, chaired by the Arab Republic of Egypt on Sunday, 7<sup>th</sup> May 2023,**

- *Having considered*,
    - Note no. 1334 submitted by the Permanent Delegation of the Arab Republic of Egypt on 3<sup>rd</sup> May 2023,
    - Note no. 485/5 submitted by the Secretariat of the League of Arab States on 3<sup>rd</sup> May 2023,
  - *Recalling* the efforts by the Arab States to evacuate nationals of Arab and foreign countries,
  - *Recalling* Communiqué No. 252 issued by the Extraordinary Session of the Council of the League of Arab States at the Permanent Representatives Level convened on 16<sup>th</sup> April 2023, concerning developments in the Republic of Sudan, as well as Resolution 8913 issued by the resumed Session of the Arab League Council at the Permanent Representatives level convened on 1<sup>st</sup> May 2023,
  - *Having been briefed* by the interventions of the heads of delegation,
- 1- *Emphasizes* the importance of fully respecting Sudan's sovereignty, unity, and territorial integrity, non-interference in its internal affairs, addressing the current crisis as an internal Sudanese affair, preserving Sudan's national State institutions, averting their collapse, and preventing any external interference in Sudanese affairs to avoid fueling the conflict and endangering regional peace and security;
  - 2- *Decides* to establish an Arab ministerial liaison group comprised of the Kingdom of Saudi Arabia, the Arab Republic of Egypt and the Secretary-General to undertake the following:
    - A. Liaison with Sudanese parties, influential regional and international countries, as well as relevant international organizations and blocs in order to resolve the crisis,
    - B. Exerting efforts to achieve a complete and sustainable ceasefire,
    - C. Working to resolve the causes of the crisis in a way that meets the Sudanese people's aspirations for stability and security,
    - D. Coordination with the Secretariat and international and UN relief organizations and bodies to provide urgent humanitarian and medical assistance for citizens and displaced persons within Sudan, through the competent authorities, as well as for those seeking a safe haven in neighboring countries that host refugees, to assist these countries in bearing the increasing burdens; and urging Arab and international donor countries to provide humanitarian aid to the brotherly Sudanese people;
  - 3- *Requests* the Secretary-General to follow up on the implementation of this Resolution's provisions; and to update the Council of recent developments.
