on

Israel's ongoing crimes of genocide, aggression against the Palestinian people, and colonial expansion in the occupied West Bank

Israel's ongoing crimes of genocide, aggression against the Palestinian people, and colonial expansion in the occupied West Bank

The League Council, at the level of Permanent Delegates, held an extraordinary session on Thursday, July 4, 2024, under the presidency of the Republic of Yemen (the interim presidency of the Ministerial Council). The session was convened at the request of the State of Palestine and supported by member states to discuss the necessary steps to be taken by the Arab States and the international community to stop the genocide and Israeli aggression committed by Israel, the occupying Power, against the Palestinian people over the past nine months. The session also aimed to address the recent decisions of the Israeli occupation government to impose sanctions and aggressive measures against the State of Palestine, which are intended to prevent the realization of its independence, intensify the annexation of the occupied West Bank, expand settler colonialism, undermine the powers and authorities of the Palestinian government, pirate its funds, and impose sanctions on Palestinian officials.

Having considered:

- The note of the Permanent Delegation of the State of Palestine No. 1096/MS/2024 dated June 29, 2024,
- The note of the General Secretariat,
 - Reaffirms its strong condemnation of the genocide committed by Israel against the Palestinian people, characterized by systematic and intentional killing, starvation, and destruction of all forms of life for hundreds of thousands of Palestinian civilians in the Gaza Strip,
 - Reaffirms its strong condemnation of widespread Israeli crimes against the Palestinian people in the occupied West Bank, including East Jerusalem, which aim to systematically destroy Palestinian refugee camps and their infrastructure with the intention of re-displacing them and obliterating their cause. This includes daily raids on dozens of Palestinian cities, villages, and camps, the terrorizing actions of Israeli settlers, the killing and injuring of hundreds of Palestinian citizens, the demolition of homes, and the burning and vandalizing of farms and property, as well as the arrest of thousands of Palestinians under inhumane conditions,
 - *Emphasizes* all its previous decisions regarding the Palestinian issue, which remains the central issue of the Arab nation, including support for the Palestinian people in their legitimate struggle against the Israeli occupation, their right to return, self-determination, and the realization of an independent State of Palestine along the June 4, 1967 borders with Jerusalem as its capital,
 - *Having reviewed* the speech of the Permanent Representative of the State of Palestine.

- 1. Warns that Israel's ongoing crime of genocide against the Palestinian people, its refusal to abide by Security Council resolutions related to the ceasefire, and its disregard for the binding orders of the International Court of Justice to stop harming civilians and address their humanitarian needs, constitute an assault on the international system, undermining international law and human values; and urges the international community and the Security Council to implement a decisive intervention to stop the genocide immediately and prosecute Israel for its crimes;
- 2. Strongly condemns the aggressive policies and measures taken by the Israeli occupation government against the State of Palestine, which aim to prevent the realization of its independence, including intensifying plans to annex occupied West Bank territories, expanding settler colonialism, legitimizing five settlement outposts in strategic areas of the West Bank, licensing and constructing thousands of new settlement units, undermining the civil and economic powers of the Palestinian government in approximately 80 percent of the West Bank, pirating funds from the Palestinian government and people, and imposing sanctions on Palestinian officials;
- 3. *Emphasizes* that the Israeli occupation government's attempts to annex any part of the Palestinian territory occupied in 1967, either directly or through invalid legislation, constitute a new Israeli war crime; *and calls on* the international community to exert deterrent pressure and punitive measures on Israel to stop its illegal annexation and settlement plans, which eliminate the chances of achieving peace and the two-state solution;
- 4. *Requests* the General Secretariat to coordinate with member states to implement the Arab Summit Resolution 854 in its 33rd Ordinary Session, held in Bahrain on May 16, 2024, including adding extremist Israeli organizations and groups that storm the Al-Aqsa Mosque and are linked to Israeli colonial settlements to the Arab national terrorist lists, as reported by the Permanent Representatives Committee on January 30, 2024, announcing the list of shame containing Israeli figures who incite genocide against Palestinians to facilitate legal measures against them and hold them accountable at national and international courts, and boycotting all companies operating in Israeli colonial settlements in Palestinian and Arab territories occupied since 1967, as listed in the updated Human Rights Council database of June 30, 2023. (Lists attached);
- 5. Reaffirms the categorical rejection of the Israeli occupation government's plans following the aggression; affirms that the Gaza Strip is an integral part of the State of Palestine; supports the efforts of the Palestinian government to assume governance responsibilities in the Gaza Strip, the West Bank, and East Jerusalem, and its efforts to establish peace, security, and stability in the region, based on ending the Israeli occupation and realizing the independence of the State of Palestine along the 1967 borders, with Jerusalem as its capital, in accordance with approved international references;

- 6. *Tasks* the Arab Group in New York with exploring measures to suspend Israel's participation in the United Nations General Assembly due to its failure to adhere to the purposes and principles outlined in the United Nations Charter, its threat to international peace and security, and its non-compliance with obligations that were conditional for its membership in the United Nations;
- 7. Strongly condemns ongoing and perilous Israeli military attacks on southern Lebanon, resulting in the deaths of civilians, including children, women, the elderly, journalists, and paramedics and extending deep into Lebanese territory, targeting Lebanese army installations and causing destruction to villages and agricultural lands, often employing internationally prohibited white phosphorus; calls for exerting international pressure to thwart Israel's declared intention of launching a widescale war on Lebanon and compel it to end its occupation of remaining Lebanese lands in Shebaa Farms, Kfar Shuba Hills, and the outskirts of al-Mari town, withdraw beyond internationally recognized borders, and cease violations of Lebanon's sovereignty by land, air, and sea;
- 8. *Condemns* repeated Israeli assaults on Syrian Arab Republic territory, which flagrantly violate its sovereignty, territorial integrity, international law, and the Disengagement Agreement; *affirms* support for the Syrian Arab Republic's exercise of its right to defend its territory and people; *and urges* the Security Council to fulfill its responsibilities by restraining these attacks and ending Israel's occupation of the Syrian Golan Heights up to the June 4, 1967 borders, in compliance with relevant resolutions, including Resolutions 242, 338, and 497;
- 9. *Reaffirms* support for all measures and policies undertaken by the Arab Republic of Egypt to address the repercussions of the severe Israeli aggression in Gaza, prevent the undermining of the Palestinian cause, and defend its national security, which is integral to Arab national security;
- 10. Commends international and popular solidarity with the Palestinian cause against Israel's genocide against the Palestinian people; acknowledges diplomatic and legal efforts by states and human rights organizations within international justice mechanisms, including the International Court of Justice and the International Criminal Court; encourages all states to join these efforts and initiatives; and urges civil society organizations, Arab human rights unions, and federations to initiate legal proceedings against Israeli officials in national and international courts;
- 11. *Commends* the United Nations Secretary-General for including Israel, the occupying power, on the annual "blacklist" of organizations and countries that violate children's rights in conflict areas;
- 12. *Reaffirms* support for the efforts of Algeria, as an Arab member of the Security Council, aimed at halting Israeli aggression against the Gaza Strip and other occupied Palestinian territories, and condemning the genocide committed by Israel against the defenseless Palestinian people;

- 13. *Supports* joint Egyptian-Qatari efforts aimed at reaching a permanent ceasefire and restoring life to normalcy in the Gaza Strip;
- 14. *Expresses* regret over the Security Council's failure to fulfill its responsibilities in promptly and effectively implementing a ceasefire, as mandated by Resolution No. 2735 dated June 10, 2024, to facilitate the delivery of humanitarian aid to the Gaza Strip;
- 15. Welcomes and commends the growing recognition of the State of Palestine by more countries worldwide; calls on countries that have not yet recognized Palestine to do so in accordance with international legitimacy, recognizing this as a legitimate right of the Palestinian people and a step toward promoting peace, security, and stability in the region and globally; and supports the State of Palestine's full membership in the United Nations through a Security Council Resolution;
- 16. *Condemns* Britain's obstruction of international justice and delay in ensuring justice for victims, including its request to the International Criminal Court to submit written observations on whether the Court can exercise jurisdiction over Israeli citizens; *and holds* Britain legally and morally responsible for the actions that enable perpetrators to evade accountability and reflect double standards;
- 17. *Urges* the International Criminal Court to proceed with its investigations and prosecutions of Israeli officials responsible for genocide, crimes against humanity, war crimes, and aggression against the Palestinian people;
- 18. Warns that ongoing Israeli practices heighten the risk of dangerous regional escalation;
- 19. *Requests* the Councils of Arab Ambassadors and League of Arab States missions abroad to actively pursue the implementation of this Resolution through their respective foreign ministries, relevant agencies in host countries, and affiliated organizations;
- 20. *Tasks* the Secretary-General of the League of Arab States with monitoring and reporting on the implementation of this Resolution at the next League Council session;

Tunisia supports the Resolution but does not endorse references to "borders of June 4, 1967," the "two-state solution," and "East Jerusalem." Tunisia maintains a firm position supporting the Palestinian people in their struggle to regain their legitimate rights, including the establishment of an independent and sovereign state with Jerusalem as its capital.

1	Gush Emunim Movement (Group of Believers)	Storming Al-Aqsa	Raises the slogan "The Land of Israel for the People of Israel", aims to impose religious sovereignty over all the land of Palestine, demolishing Al-Aqsa Mosque and building the temple.
